# STM Submission to the EU Commission's Consultation on the Directive on the re-use of public sector information

The International Association of Scientific, Technical and Medical Publishers (STM) is the leading global trade association for academic and professional publishers. It has 145 members in 21 countries who each year collectively publish nearly 66% of all journal articles and tens of thousands of monographs and reference works. STM members include learned societies, university presses, both subscription and open access publishers, new starts and established players.

STM welcomes this opportunity to make this additional submission as part the Public Consultation on the Review of the Directive 2003/98/EC on the Re-Use of Public Sector Information (PSI Directive), amended by Directive 2013/37/EU in July 2013.

In general, STM supports the aims of the PSI Directive and bolster the inclusion of raw data (published outside of a scientific publication) and certain forms of so called grey literature in the scope of the PSI Directive, where such raw data or grey literature has been created by the public sector and the copyright subsisting therein is owned by the public sector. The best way to make such raw data and grey literature available may well rest in the formation of public-private partnerships. However, when information has been enhanced or had value added (e.g. indexing, thesaurus, hyperlinks, consolidation, etc.) to it by a third party, for example through the publication in a journal, such information should not fall within the scope of this Directive. This information should be made available to the public based on licenses with commercial terms.

With the above in mind, STM fully supports the clear expression in several recitals and articles of the PSI Directive that copyright and the value-add of the private sector must be respected in the way the PSI Directive is applied. STM opposes the extension of PSI and PSI policies to include original copyright-protected works published by the private sector only because these works may embody or build on PSI.

STM welcomes this opportunity to contribute constructively to the debate by giving its opinion to the following section in the online survey on which STM has a particular interest:

Section: Data held by educational and research establishments/scientific information.

Comments to questions 12a and 12b:

#### Question 12a:

Do you agree that scientific research results (publications and research data) resulting from public funding should in principle be open access (free of charge online access and unrestricted reusability)?

STM's reply to this question is submitted as a free comment because a simple "yes or no" answer does not seem appropriate for this purpose. STM fully agrees and supports the principle of FAIR – findable, accessible, interoperable and reusable – data. However, this question conflates research results resulting from public funding with published articles and research data; these are not the same and publications (which include text and data) has significant value added to them by publishers, who needs to recoup these investments through different models of access.

With respect to the principle of Open Access to research data there are additional considerations: it should be noted that among researchers there is at times serious concern for sharing their data, certainly if done too early before proper processing and validation of the data has taken place — or that the data contains information which may reasonably be expected to provide knowledge, products, or technologies that could be directly misapplied by others to pose a threat to public health and safety, agricultural crops and other plants, animals, the environment, or materiel. For this reason, STM supports consultation with the research community about ways in which researcher-validated data can be made accessible without prejudicing the creators of that data or causing a threat to human, animal, or environmental safety.

If and when privacy-issues are at stake, such as often can be the case in medical data, or other legal issues, including patenting and intellectual property issues, embargos on the openness of data may be necessary.

With respect to the principle of Open Access for publications, STM <u>supports any and all sustainable</u> <u>models of access that ensure the integrity and permanence of the scholarly record</u>. STM publishers are agnostic about business models and offer therefore a variety of options. Those include 'gold' open access, whereby publication is funded by an article publishing charge paid by the author or another sponsor, a subscription-based journal, or any one of a number of hybrid publishing options. With respect to Green OA, STM publishers believe that it can be consistent with fostering a viable system for funding publications of authoritative communications about research commonly referred to as "final published article" or "Version of record". However certain key factors should be taken into account by all stakeholders when setting and developing their Green OA policies<sup>1</sup>. Because different

business models may work best in different circumstances, STM's view is that no single business model should be required for all situations.

STM believes that authors should be able to publish in the journal of their choice, where publication will have the greatest potential to advance their field and fully supports progressing Open Access in ways that respect researcher choice and the diverse approaches to open access taken across different parts of the world, both outside and within Europe.

Question 12b:

To which extent would you agree with the following statements?

Documents held by educational and research establishments, schools and universities that are of scientific nature should become available for re-use with as few restrictions as possible (other than those necessary to preserve individuals' privacy, commercial confidentiality and legitimate rights of third parties, etc.).

STM takes a neutral position to the above statement but like to add the following explanatory comments:

Documents can include any numbers of items, ranging from public funding-only items to items that have had value added to them by the commercial sector. It is not appropriate nor it is necessary to consider the inclusion of those items that have had added value to them by third parties within the scope of the PSI Directive.

Regarding research data, it is important to use clear definitions. STM supports the FAIR (findable, accessible, interoperable and re-usable) principle and agrees that raw research data, for example results of observations or experimentations that validate research findings but are not already published as part of a journal article, should be made freely available with minimal re-use restrictions. However, researchers`concerns as noted in the prior question needs to be adequately addressed.

Science is best advanced by allowing as many scientists as possible to have access to as much valid data as possible. This avoids costly repetition of work and allows creative new integration and reworking of existing data.

It should be noted that hosting, maintaining and preserving raw data or data sets, and continuing to make such data available over the long term, has a cost which, in certain circumstances, the host site may need to recover. We recognize that on occasion the generation of data has been privately funded, and the funding entity may have a particular reason for restricting access to the data (either temporarily or permanently), and we believe these should be respected.

In conclusion, STM supports making researcher-validated data and grey literature available through open access models or private-public partnerships, in consultation with the researchers involved. However, it is crucial that copyright protected content and the value-add of the private sector must

be respected in the way PSI legislation is applied. PSI policies should not be established to engulf private sector information and private sector value-added information, including copyright protected works and materials originated and first published by the private sector.

STM supports the submission of the Federation of European Publishers (FEP).

#### Context and purpose of the consultation

The Commission is launching a public consultation in view of reviewing the Directive on the re-use of public sector information (PSI Directive). As foreseen in the May 2017 Mid-Term Review of the Digital Single Market strategy (COM(2017) 228), and in order to fulfil the goals of the strategy in the field of the data economy, the Commission is preparing an initiative on accessibility and re-use of public and publicly funded data, and is at the same time further exploring the issue of privately held data which are of public interest.

The <u>Directive 2003/98/EC</u> on the re-use of public sector information is a core element of the European strategy to open up government data for use in the economy and for reaching societal goals. Revised by Directive 2013/37/EU (PSI Directive) in July 2013, it encourages Member States (MS) to make as much material held by public sector bodies available for re-use as possible to foster transparency, data-based innovation and fair competition.

The European Commission launches the review of the PSI Directive, fulfilling the periodic review obligation contained in its article 13, and at the same time furthering the goals of the DSM Strategy in the field of data economy.

The questions of this online consultation cover both the evaluation of the current Directive implementation and the problem, objectives and possible options for the future.

#### **Explanatory remarks:**

This consultation concerns primarily the evaluation and review of the <u>Directive on the re-use of public sector information</u>.

The first part of the survey (Q1-Q8) concerns the evaluation of the implementation and functioning of the current EU legislative framework on the re-use of government data (PSI Directive).

The second part of the survey (Q9-Q18) looks into the possible improvements of this framework in the future.

The third part of the survey (Q 19a-Q21b) reflects the current discussion on the possibility to allow public sector bodies to access and use data coming from private sector entities, whenever this would be justified by public interest considerations.

You are welcome to reply to any part of the questionnaire separately or to all three parts of the questionnaire at once.

The Directive leaves intact and in no way affects the level of personal data protection under the provisions of EU and national law. All current and future provisions of the Directive will have to be implemented and applied in full compliance with the principles relating to the protection of personal data.

The Directive employs the term 'document' to refer to any content, whatever its medium (paper, electronic, sound, visual, etc.) and any part of such content. For the purposes of the present consultation, this term may be replaced by words such as 'data', 'dataset' or 'information'.

Documents held by public sector bodies but covered by third party Intellectual Property Rights are excluded from the scope of the Directive. They are therefore not affected by the current consultation exercise.

## **PART I: EVALUATION**

The PSI Directive was adopted in 2003 and subsequently amended by the Directive 2013/37/EU. The purpose of this part of the questionnaire is to help the Commission assess whether the Directive in its current shape has met the needs of citizens and business and to assist the Commission in making the legal framework simpler and less costly to apply.

The PSI Directive provides a common legal framework for a European market for government-held data (public sector information). The main objective of the Directive is to remove barriers that hinder the re-use of public sector information throughout the European Union. It harmonises the rules and practices relating to the exploitation of such information to stimulate the creation of new data-based services and products.

Any PSI review approach must distinguish between:(i) measures aimed at making PSI accessible to the general public, whether open access or otherwise, (ii) measures encouraging the re-use and value-add, in other words, the refinement and enhancement of PSI.

Whilst it is true that the Public Sector generates a wealth of data and this data in its unpublished, unstructured and uncertified form constitutes a resource from which knowledge may emerge, publishers and the private sector to a large extent assist in the germination, registration and verification of such knowledge. Publishers, not only assist in the provision of access to the public in useful, structured ways (sub ii), but are re-users of PSI which enhances the latter by, for example, promulgating PSI, updating data, tailoring search functions, alert systems, verifying data, categorizing/structuring data and preserving data, to name but a few. Policies intended to maximize goal should not at the same time undermine same goal.

#### **EFFICIENCY OF THE PSI DIRECTIVE:**

The Directive aims to generate socio-economic benefits by limiting barriers to an open re-use of government data. At the same time, the implementation of the Directive may incur compliance costs on the side of the public sector bodies.

The Directive aims to facilitate search for documents held by public sector bodies and to make data easier to process by computers. To that end it recommends publishing data and metadata in machine-readable, open formats (Art. 5). The Directive refers also to dynamic data (e.g. data from sensors or satellites) in its recital 12, but contains no obligation for public sector bodies to make this data available in a timely manner.

#### **CHARGING RULES:**

The Directive contains rules that prevent public bodies from setting excessive or arbitrary charges on the re-use of documents. Since the revision of the Directive in 2013, the default rule for charging for the re-use of public sector information is that of marginal cost of dissemination (Art. 6.1). Some exceptions to this rule are foreseen (e.g. when public bodies are required to generate revenue to cover substantial part of their operating costs). The Directive specifically mentions the rules on charging as one of the areas that may require legislative change in the present review.

It is crucial for the rights of publishers to be respected and any content on which publishers enjoy copyright, should not be considered public sector information. Therefore, content held by Cultural Heritage Organizations on which copyright subsits should not be regarded and treated as Public Sector Information.

Open access to scientific publications and research data are considered to be an important enabler of innovation and scientific progress. The Commission Recommendation of 17 July 2012 on access to and preservation of scientific information recommends that Member States, research funding organisations and academic institutions put policies in place that ensure that scientific research results (publications and research data) are in principle available on an open access basis (free of charge online access and unrestricted re-usability).

Services of general interest (e.g. public transport, postal services, healthcare) can be provided either directly by the state or by publicly controlled companies or on behalf of public authorities by independent economic operators (e.g. under a concession contract).

The data generated whilst providing services of general interest either by publicly owned companies or by independent economic operators on the basis of contracts are often exempt from the provisions of the PSI Directive. This may create an imbalance across the Member States, given that in some of them similar tasks are carried out by public sector organisations directly. As a consequence, the creation of pan-European information products based on this type of data might become difficult.

RELATIONSHIP WITH THE DATABASE DIRECTIVE:  As a rule, the provisions of the PSI Directive do not affect intellectual property rights (IPRs) including sui generis rights (recital 22), while indicating that rights held by public sector bodies should be exercised in line with the provisions of the PSI Directive. Despite this, some public bodies have been tempted to invoke their sui generis right under the Directive 96/9/EC (Database Directive) to prevent the re-use of the content of their databases.

NATIONAL ACCESS REGIMES:  The PSI Directive distinguishes between the notion of 'access' and that of 're-use'. The Member States are responsible for deciding which documents cannot be accessed (e.g. on the grounds of protection of national security, commercial confidentiality or in cases where existence of particular interest to access needs to be proved). If a document is not expressly excluded from access by national legislation, it becomes automatically available for re-use under the terms of the PSI Directive.  Q16: In this light, which of the following statements would you support (more than one option is possible)?  The link between access and re-use is clear and useful. It prevents the release of documents the
re-use of which could harm the interests of the state, individuals or third parties.
